

## **Pension Application for Isaac Green**

A.13213

Declaration. In order to obtain the benefit of the act of Congress passed June 7th 1832.

State of New York

County of Chenango SS.

On this 20<sup>th</sup> day of July in the year 1832 personally appeared before me Nathan Taylor one of the Judges of Chenango County Courts Isaac Green a resident of Columbus County of Chenango & State of New York aged 68 years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed June 7<sup>th</sup> 1832.

That he entered the service of the United States under the following named officers and served as herein stated.

About the first of May 1778 he went with a company of Militia commanded by Captain Southerland in Colonel Humphrey's Regiment to West Point in the State of New York & served two months and was discharged at West Point about the first of July.

That in July in the year 1780 from Patterson in the County of Dutchess State of New York now County of Putnam went as a volunteer in Captain Gilbert Livingston's Company, Colonel Dubois for the term of four months went first to Fishkill then to West Point thence to Harvestraw [Haverstraw] then back to West Point then up to the Mohawk river spent most of the time on the Mohawk at the expiration of the term of four months at the poliutation of the officers staid as nigh as I can recollect half a month longer & in this time at Stone Robbie near Fort Plain was in a battle with the English & Indians the day after the battle followed them & pursued the three days without a mouthful of provisions after returning to Fort Plain was discharged & went home.

About the last of May or first of June 1781 was drafted & went in a company of Militia capt. Ditman or Dikeman, Col. Lutherton to West Point & served from three or six months can not be certain which & was discharged at West Point.

On the first of April 1782 I enlisted in or was attached to Capt. Andrew Moody & company in Colonel John Lambs Regiment of Artillery and served nine months & was discharged at West Point at which place this term of service was performed that this last term of service was in the regular army New York line that he joined it as one of the new levies (so called). That in the first tour at West Point he thinks that Col.Putman was a regular officer at that part in his other terms of service has seen General Washington LaFayette & knows but cannot now state which particular term.

I was born in Fredericstown Dutchess County State of New York March 28<sup>th</sup> 1764. I have a record of my age in my family Bible.

I was living in the nine partners Dutchess Co. when called into the service for the first two months & lived in the Southeast Dutchess County when called into service the other three terms.

I lived a few years after the Revolution in Southeast Dutchess County from there removed to Pittstown Rensselaer Co. from thence to Galaway [Galway] Saratoga County from thence to Columbus Chenango County where I have lived about thirty years and where I now live. I would state the names of Samuel Campbell late member of Congress, Joshua Lamb PostMaster Columbus Corners, Capt. Abel DeForest, Gen. A.D. Welch of New Berlin of whom the department can make any enquiries in regard to my character & Revolutionary Services.

I hereby relinquish every claim whatever to a pension or annuity except the present and declare that my name is not on the pension roll of the agency of any state.
