

**Pension Application for John Hugian or Hughan**

R.7559 (Former widow: Sarah Nash) Married October 16, 1774, died October 1795. Sarah was after married to John Nash of Ballston January or February 1797. John Nash died October 1, 1834. Sarah died September 22, 1838.

Surviving Children:

1. Nancy Wilkins wife of Jonathan S. Wilkin of Ballston in the County of Saratoga NY.
2. Eliza Stephens wife of Frederic Stephens of New Milford in the County of Susquehannah PA.
3. Thomas B. Hughan went to South America about twenty years of age, place of residence not heard from since, supposed to be dead.
4. Lydia Bramly wife of George Bramly, who about 20 years ago resided in Sorel, Lower Canada and about fifteen years ago—it was understood and believed that she with her family moved to Europe and not heard from since.

Be it known that before me the undersigned a Commissioner of Deeds in and for said County personally appeared, Nancy J. Wilkins wife of Jonathan S. Wilkins now residing in Ballston in the County of Saratoga aforesaid, aged fifty one year last February; who being first duly sworn according to law, depose and say that she is one of the children of John & Sarah Hughan (otherwise called Hugian) that her Father the said John Hughan died in Ballston in the County of Saratoga in the State of New York—some time in Ballston in the County of Saratoga in the State of New York—some time in October 1795—

That he left him surviving the aforesaid Sarah Hughan his lawful widow, that she continued to be the widow of the said John Hughan until January or February in the year of our Lord 1797, she was married to John Nash of Ballston aforesaid with whom she lived as his wife until his decease; and that the said John Nash of Ballston aforesaid with whom she lived as his wife until his decease; and that the said John Nash was then a resident inhabitant in the County of Broom in the State of New York on the 1<sup>st</sup> day of October 1834, that he left him surviving he said Sarah, his lawful widow, and that she continued to be his widow until the day of her death, and further she deposes and says that according to the best of her knowledge information on belief, her mother the said Sarah Nash widow of the said John Nash (& formerly the widow of John Hughan as above mentioned) died, on the 22<sup>nd</sup> day of September in the year of our Lord, one thousand eight hundred and thirty-eight; in Springville in the County of Susquehanna in the State of Pennsylvania.

And further deponent says, that she has been informed by her mother & has always understood from her earliest infancy, that at the commencement of the war of the Revolution, deponents parents, aforesaid, resided in Schenectady in the then, County of Albany, that after the said War commenced, they moved to Newburgh in the County of [blank] in the State of New York, where they continued to reside until they

moved to Ballston which was soon after the war closed. He was generally known by the name of John Huga.
