

### **Pension Application for Timothy Hutton**

W.18086 (Widow: Elizabeth) Timothy died October 10, 1824. Surviving children: George, William, Isaac Hutton and Harriet Coons & Elizabeth Babcock.

State of New York of the County of Schoharie and Town of Carlisle SS.

On this eleventh day of May one thousand eighth hundred and thirty nine personally appeared before the undersigned a Justice of the Peace in and for the County of Schoharie Elizabeth Hutton a resident of the Town of Carlisle in the County of Schoharie and State of New York who being first duly sworn according to Law doth on her oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July 4<sup>th</sup> 1836.

That she was born on the 24<sup>th</sup> day of October 1760 and is in the seventy ninth year of her age that she is the widow of Timothy Hutton who was an Ensign in Capt Henry Oothoudt's Company in Philip P. Schuyler (1) Regiment of Militia for the County of Albany and was promoted to Lieutenant in the year 1780 (2) in the same regiment and in 1781 was appointed Lieutenant in a Regiment of Levies under Colonel Marinus Willett, (3) of the State of New York—and that he served the most of his time during the revolutionary war and was at Schoharie and on the Mohawk River and at the taking of Burgoyne at Seratogo [Saratoga] and that I saw him on duty with his company in Schenectady (the year before we where [were] married) wich [which] was 1781 and that I then understood that he was an officer in Willett's Regiment but I cannot State the time he served in the diferent [different] expeditions but from the knowledge I have from what I understood from my husband and others that he served the greatest part of the time.

She further declares that she was married to the said Timothy Hutton on the thirteenth day of July 1782 in the City of Schenectady by Revd Mr. Vrooman and that [?] my husband the aforesaid Timothy Hutton died on the tenth day of October 1824 and that I have remained a widow ever since that period and that he lived in the Town of Watervleet [Watervliet] till after the war and then removed near Troy, and about 1796 removed to Charleston Montgomery County and about twenty years after to the Town of Sharon in Schoharie and then to Carlisl

[Carlisle] where my husband Timothy Hutton died and that I have nine children four sons and five daughters by Timothy Hutton, and I further swear that I am not able to attend personally in court by reason of bodily weakness and infirmity. All which [which] will more fully appear by reference to the proof hereto annexed. (Signed with her mark) Elizabeth Hutton. In presence of Henry J. Moak, Justice of Peace and Commissioner

Letter in folder dated October 21, 1929, written in response to an inquiry.

I advise you that from the papers in the Revolutionary War pension claim W.18086, it appears that Timothy Hutton was born November 24, 1746, place not stated, while residing in Watervliet, New York, he enlisted in 1777 and was an Ensign in Captain Henry Oohoudt's Company, Colonel Philip P. Schuyler's New York Regiment. He was commissioned a Lieutenant in Captain Henry Ostrum's (5) company in same regiment, and was also a Lieutenant in Colonel Marinus Willett's Regiment and served to close of war. He was at the taking of Burgoyne.

He died in Carlisle, New York, October 10, 1824.

Soldier married February 11, 1776 Jane McChesney. She died February 18, 1781. He married July 13, 1782 in Schenectady, New York, Elizabeth Deline, who was born October 24, 1760. She was allowed pension on her application executed May 11, 1839, while a resident of Carlisle, Schoharie County, New York. She died in Schoharie County, New York, September 21, 1844, leaving the following children: George Hutton, William Hutton, Isaac Hutton, Harriet Coons and Elizabeth Babcock.

The family record also shows that Isaac Hutton was born May 22 or 24, 1799, one of the sons of Timothy and Elizabeth Hutton, was married January 26, 1822 to Elizabeth Carlisle who was born September 23, 1799.

End Notes—Timothy Hutton – W.18086

1. Timothy most likely served as an enlisted man in 1775 and 1776 in Captain Abraham D. Fonda's Second Company in Colonel Abraham TenBroeck's Third Regiment of Albany County Militia. Colonel TenBroeck was appointed brigadier general of the Albany County Militia and Lieutenant Colonel Francis Nicholl was promoted to Colonel on February 20, 1776. On Colonel Nicholl resigning Philip P. Schuyler was appointed Colonel of the Third Regiment of Albany County Militia. Captain Fonda was promoted to major of the same regiment. Both were commissioned on June 22, 1778. Henry Oothoudt Jr was the first lieutenant of Captain Fonda's Company and was promoted to Captain and was also commissioned on June 22, 1778. The following also were

commissioned on the same date: Levinus Lansing as the first lieutenant, Jacob John Lansing as the second lieutenant and Timothy Hutton as the ensign.

2. On Captain Oothoudt resigning, First Lieutenant Levinus Lansing was promoted to Captain, Second Lieutenant J.J. Lansing was promoted to first lieutenant, Timothy Hutton to second lieutenant and John Shaver was appointed ensign. They were all commissioned on March 4, 1780. New York State Deputy Comptroller on August 28, 1846 submitted several pay receipts for Timothy Hutton for proof of service but several were for a different Timothy Hutton. There were four that did pertain to this Timothy Hutton and they were all for service in Captain Lansing's Company: 1779 Nov 7, 28385 for £1. . 11. . 5, 1779 Nov 3, 28464 for £ 2. . 17. . 3 1/3, 22 Oct 1781, 28492 for £ 5. . 11. . 6 2/8 and 2 Nov 1781, 28534 for £ 3. . 13. . 0.
3. This Timothy Hutton did not serve in Lieutenant Colonel Commandant Marinus Willett's Regiment of New York State Levies at any time period. Refer to Timothy Hutton PA S.1025 on pp 223-226 in Book 6 of Don't Shoot.
4. Lieutenant General John Burgoyne had two major battles with American Troops on September 19 and October 7, 1777. Burgoyne surrendered the remnants of his army on October 17, 1777.
5. Henry Ostrom, Ostram or Ostrum was a Captain in Colonel Schuyler's Regiment but Hutton was not part of this company. Hutton most likely served in a detachment of men drafted from several of the companies from Schuyler's Regiment and Captain Ostrom may have been selected to command the detachment.
