

District of New Jersey. Bergen County. On the 14th June 1820 before the judge of the Court of Common Pleas for the County of Bergen personally appeared in open court, being a Court of record, possessing a Seal, having a Jurisdiction unlimited in point of amount and proceeding according to the course of common law, JOHN LIGHPIPE aged sixty eight years, who being first duly sworn according to law doth on his oath declare that he served something better than nine months as a soldier in the Revolutionary War in CAPT. SEELY's Company, GENL. HAZENS Regiment. That the date of his original application was on the 7th April 1818. That he has received a certificate from the War Department as a Pensioner inscribed on the pension roll list of the New Jersey agency dated being number and I do solemnly swear that I have not since that time by gifts, sale, or in any manner disposed of my property or any part thereof with intent so to diminish it as to bring myself within the provision of an Act of Congress entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" passed the 18th March 1818. And that I have not nor has any person in trust for me any property or securities, contracts or debts due to me, nor have I any income other than what is contained in the schedule hereto annexed, and by me subscribed; that my occupation has been that of a weaver. That my family consists of myself and my wife POLLY that my wife for some time has not been able to labour, and at this time is confined to her sickbed with the dropsey. That for myself I am sickly and unable to do any labour for some years suffering under a pulmonary complaint, and that the small property I possess is not sufficient for my support and my family without the kind assistance of my Country.
