

## **Pension Application for Amiable Paulint or Paulient**

At a Court of Common Pleas holden at the Court-House in Plattsburgh, in and for the County of Clinton, and State of New-York, on the third day of October 1820. Present Elisha Arnold, Caleb Nichols, Nathan Carver & A. R. Moore, Esquire. Judges of the said Court.

County of Clinton SS.

On this third day of October 1820 personally appeared in open Court, it being a Court of Record proceeding according to the course of the common law, and having the power of fine and imprisonment, and keeping record of their proceedings in and for the County of Clinton, Amiable Paulient aged fifty two years resident in the town of Chazy in the said County of Clinton, who being first duly sworn according to law; doth on his oath declare that he served in the revolutionary war as follows: that he the said Amiable Paulient enlisted for and during the war sometime in the spring of the year 1781 in the State of New York in the company commanded by Captain Antone Paulient in the regiment commanded by Colo. Moses Hazen in the line of the State of New York on the Continental establishment that at [?] New Jersey he joined the company commanded by Captain Lilly same regiment. That in the fall of the year 1782 he was transferred into Capt. Clement Goshen Company same regiment & B line of troops, that he continued to serve in the said corps until peace when he was discharged from the service in New Windsor in the State of New York.

That his original declaration to obtain a pension under the Act of Congress of the 18<sup>th</sup> of March 1818 was made the sixth day of April 1819 that he has received a pension certificate Numbered 14805 and dated the sixth day of September 1819. And I do solemnly swear that I was a resident citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof, with intent so to diminish it as to bring myself within the provisions of an act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war," passed on the 18<sup>th</sup> day of March 1818 and that I have not nor has any person in trust for me any property or securities, contracts or debts due to me, nor have I any income, other than what is contained in the schedule, hereto annexed, and by me subscribed.

Real Estate. I own an undivided half of an eighty acre lot of land under pretty good employment on which is and [an] old house & a frame barn, which is so called at the time being appraised at twenty dollars—I also own the undivided half of a wild lot of land of one hundred acres very poor and stony & laying remote from any settlement and which is valued at twenty five dollars.

I am by occupation a farmer I have a wife Janet Paulient who lives with & depends upon me for support and who Charles Platt, Clerk of the Court of Common Pleas. is lame—I am myself in bad health my [???] and I have not been able to do a full days work for seventeen years past.
