

## **Pension Application for Cornelius Warner**

New-York Mayor's Court.

In the Court of Common Pleas, called the Mayor's Court of the City of New-York, held at the City-Hall, in and for the said City, before the Judges of the same Court, of June term, in the year of our Lord one thousand eight hundred and twenty, Present the Honorable Peter A. Jab, Recorder City of New-York, SS.

Be it remembered, that on the twenty fourth day of June in the year of our Lord one thousand eight hundred and twenty personally appeared in the Court of Common Pleas, called the Mayor's Court of the city of New-York, in open court, the said court being a court of record for the city and county of New-York, according to the charter of the said city and the laws of the state of New-York, Cornelius Warner aged Sixty seven years, resident in the City of New York who being first duly sworn according to law, doth on his oath declare, that he served in the revolutionary war as follows:

That he enlisted in the City of New York sometime in the year 1775 in a Company of Artillery commanded by Captain Sebastian Bauman in the New York line on the Continental establishment, commanded by Col. John Lamb, he was at the Battles of White Plains, Princeton, Trenton and Monmouth, and in several small affairs, that he served faithfully in the Continental Service as a Private, Twenty one months and about one year as a Corporal. He left the Army by permission of Lieut Reid an officers of his company being sick and unable to perform his duty and remained sick until after the expiration of his term of service, having enlisted for three years, he is unable at this time to produce any other evidence of his service, excepting the affidavits of Da n Cochran and John Reins, annexed to his first application they having served with him part of his term of service.

He is by occupation a House Carpenter but from age and debility is and has been for sometime past unable to work, he has one Daughter living with him now about 17 years of age who endeavours to assist in her own support by her Needle, he is in very Indigent Circumstances and requires the aid of his County or Individual contributions, and that his original declaration is dated the Twenty sixth day of June 1818.

And I do solemnly swear that I was a resident citizen of the United States on the 18<sup>th</sup> day of March, 1818, land that I have not since that time, by gift, sale, or in any manner, disposed of my property, or any part thereof, with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress, entitled, "An act to provide for certain persons engaged in the land and naval service of the United States, in the Revolutionary war," passed on the 18<sup>th</sup> day of March, one thousand eight hundred and eighteen: and that I have not, nor has any person in trust for me, any property of securities, contracts or debts, due to me; nor have I any income other than what is contained in the schedule hereto annexed, and by me subscribed, to wit:
