

Pension Application for Augustus Wilkie

On this twenty second day of August 1820 personally appeared in open Court, in the Court of Common Pleas of the said County, the same being a Court of Record for the said County, proceeding according to the course of the common law with a jurisdiction unlimited in point of amount, keeping a record of its proceedings and having the power of fine and imprisonment, Augustus Wilkie, aged seventy years, resident in the said County, in the State aforesaid, who being first duly sworn according to law, doth, on his oath, declare that he served in the Revolutionary war as follows: for the term of three years and four months from and after the month of March in the year 1776, as a sergeant first in the company in the New York line commanded by Capt Gerrit Vedder in Colonel Vigincoops [Wyncoops] Regiment for one year, went in Capt Frenchs Company in Colonel Courtlands Regiment two years after which he hired a substitute who served in the same regiment in his room during the war he further served personally four months in Capt Mayers Company in Colonel Livingstons Regiment.

That his original declaration was made on or about the second day of April 1818 and that his Pension Certificate is numbered one hundred and sixty six.

And I solemnly swear that I was a resident citizen of the United States on the 13th day of March, 1818; and that I have not since that time, by gift, sale, or in any manner, disposed of my property or any part thereof, with intent thereby so to diminish it, as to bring myself within the provisions of an act of congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States, in the Revolutionary war," passed on the 18th day of March 1818; and that I have not, nor has any person in trust for me, any property or securities, contracts or debts, due to me; nor have I any income other than what is contained in the schedule hereto annexed, and by me subscribed. (Signed) Augustus Wilkie

A bond and mortgage executed by Joseph Hodges for the security of the payment of two hundred dollars dated the tenth of October 1818, in which bond & mortgage I have Received fifty seven dollars and seventy four cents leaving a ballance [balance] due on said bond and Mortgage of one hundred and forty two dollars and twenty six cents payable by installments with interest from date which will all become

due the tenth day of October 1822. Bone \$112.24. Interest \$18.22 \$160.48. One common pine chest \$2.00
\$162.48

The said August Wilkee [Wilkie] owes on a note executed by himself to Thomas Wilkie \$20.00 One not to Jeremiah Wilkie \$36.75.

He is by occupation a Carpenter he is totally disabled by age and infirmity from pursing it or performing any other labour his constitution verry [very] much broken and of a weak and debilitated heart [heart?] He has [?] wife, child nor home.
